Description	<p>Activities:</p> <p>Activities for this initiative include grant reporting and administration, public outreach, locating existing colonies of Grecian foxglove, mapping locations using GPS, technical assistance for landowners during site work, coordination with local government staff, and developing management strategies to control and/or eliminate Grecian Foxglove from roadsides in Washington County.</p> <p>Update 7/10/12: expanded scope of workplan approved by BWSR, to include other species newly discovered in the county</p> <p>WCD staff working on this initiative:</p> <p>Jyneen Thatcher, Natural Resources Specialist. Over 20 years of related natural resource management experience, including direct experience with managing a previous CWMA grant project for WCD. Jyneen will be the designated technical representative for all individual CWMA projects under this grant and will train WCD support staff as needed to perform required tasks.</p> <p>Performance Standards:</p> <p>Program will use the BWSR practice standard entitled "Establishment of Cooperative Weed Management Areas" to ensure that activities under the grant meet established BWSR requirements. The goal of the project is to eliminate Grecian Foxglove from Washington County roadways. To achieve this goal, tasks will include site inspections, monitoring of treatment effectiveness, training local government to build capacity, and continuing education and outreach. The program will control Grecian Foxglove as required by the Minnesota Department of Agriculture's noxious weed law.</p>
